The goods and services shown on this general price list are those we provide to our client families. Most pricing is offered as a package and no adjustments will be made for items not used. **Package pricing is not offered to those families who purchase a casket or alternative container from an outside source.** Client families may choose only those items desired from our itemized price list. All arrangement selected will include our administrative and professional service charge.

Our administrative and professional service charge includes but are not limited to a proportionate share of taxes, licenses, utilities, and business expenses required to serve the public. It also includes family consultation; administrative and clerical services; preparation of the death certificate for certification by the attending physician or coroner; consultation with clergy, cemetery, honor guard and/or common carrier; assistance with life insurance claims; placement of obituary notices; and notification to Social Security and/or Office of Personnel Management.

We offer a variety of styles and prices of caskets, alternative containers, and urns. A complete price list will be provided upon request. A casket or alternative container and urn is to be purchased or provided by the family.

For health and sanitation reasons, we require either refrigeration or embalming within 24 hours of possession of the remains.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession on the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

Some caskets may seem similar in appearance but may differ greatly in quality and construction. A complete casket price list will be provided upon request.

We hope the following assists our client families in making an informed decision.

Protective: Designed by the manufacturers to resist the entrance of air, water and other outside elements. They may be constructed of varying gauges of steel, copper or bronze.

Non-Protective: Not designed by manufactures to resist the entrance of air, water and other outside elements. They may be constructed of steel, hardwood or wood products covered with fabric.
